Please do not request a trial date beyond this 6-month session on the Civil Status Report. IF YOU AGREE with the trial date indicated for your case on the administrative calendar, you may complete #s 3-7 on the Civil Status form. IF YOU DO NOT AGREE with the trial date, please complete the entire form or provide a Consent Scheduling Order.

Additionally, the Court will hear any pending civil motions properly noticed or set by consent of the parties. Pursuant to North Carolina General Statute 1A-1, Rule 26(f1), medical malpractice discovery conferences will also be scheduled at this session for all pending medical malpractice cases. All counsel of record in a medical malpractice action should review, and be familiar with, the Administrative Order Regarding Medical Malpractice Actions dated October 14, 2021. A copy of that Administrative Order may be obtained from the local clerk or online under the Local Rules section for each individual county at www.nccourts.gov.

PLEASE NOTE all civil Superior Court calendars for the 11th Judicial District (Franklin, Granville, Person, Vance and Warren Counties) will not be posted online but CONFIRM HEARING DATES by searching for the case in eCourts Portal.
